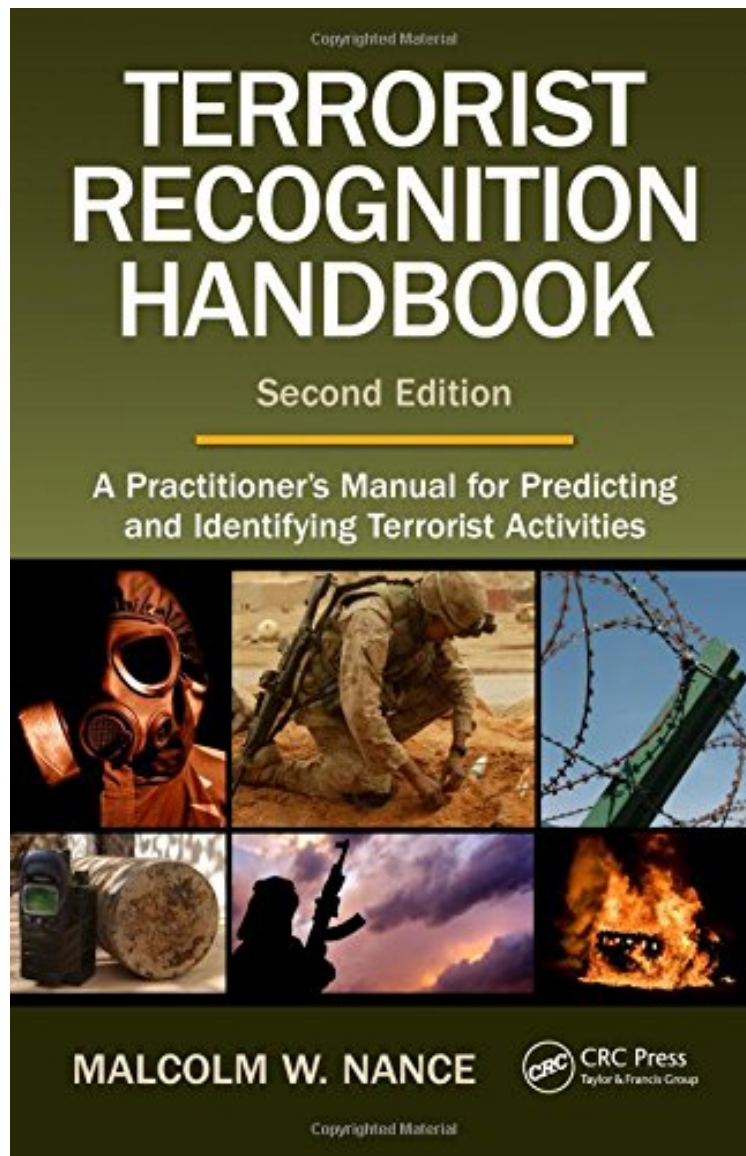

Other parts, such as the case studies, show how possible indicators had been ignored or examined that could have prevented or did prevent attacks. Also this book shows how different terrorist groups operate and their similarities which was very interesting. Even though this was written before Al-Qaeda has been taken down a few notches it still holds true and is a great reminder to continue to stay vigilant even when things seem quiet.
