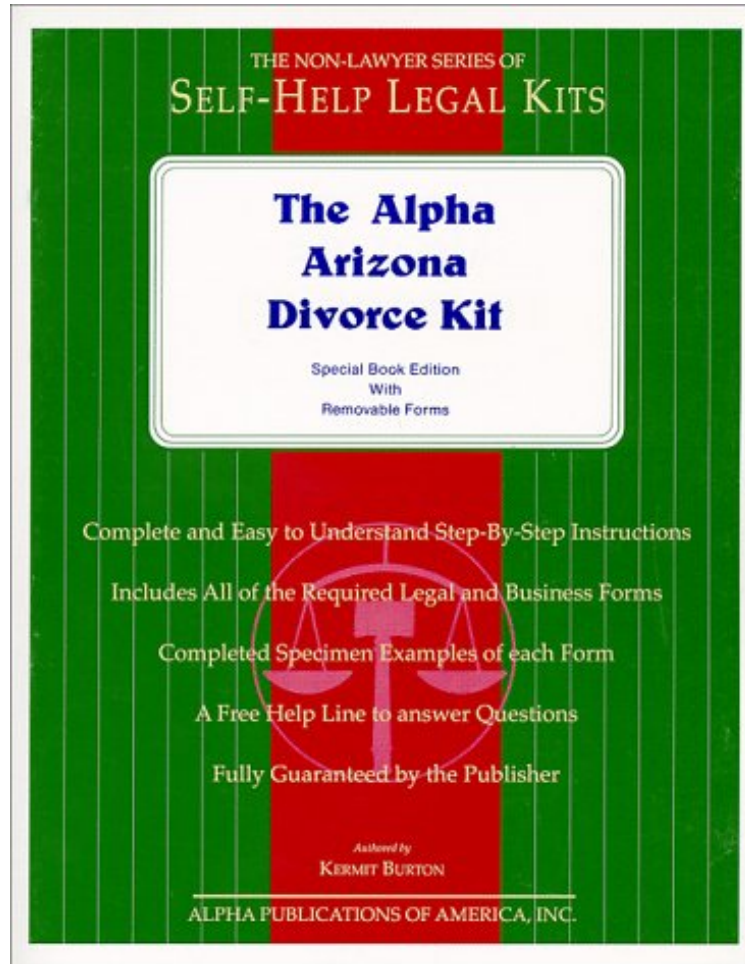

This is not an effective guide on how to complete the documents available online directly from the county. Seems ridiculous this is still being sold. It is not very comprehensive at explaining how to fill out each item on the forms, which would have some benefit when completing the current forms. If you are looking for a comprehensive guide on completing the form this is not it. I would be surprised if the clerk of the court would accept these forms and current forms are available online for free. However the available instructions are not very detailed and I was looking for a more practical application support, which this book did not provide.0 of 0 people found the following review helpful. old school, but worth the moneyBy harryzonathis is a package of forms. no disk. no pdfs. you will need to scan these and either makes copies, or convert to pdf. I converted to PDF with adobe acrobat PRO. (to make it typeable) While you can get most of the forms you need in Maricopa county from the court website,

you can not get them all. (you need your own decree form) This pack also has examples of filled forms, so you have an idea of the kind of information should be in each form. This is well worth the small price for the pack. I was able to use this and the forms from the county website to do my own. If both parties are in total agreement, then this pack is of good use. We did our own, and the only expense was the county filling fee. If you use the decree form, and do a default judgement, you will need to block out the part that says you are going to mail a copy to the respondent. (the court will mail you both copies in the envelopes you provide)Go slow. If you need help, contact an attorney.0 of 0 people found the following review helpful. Do not buy if you live in ArizonaBy CheechWarning: this review id for Arizona only, Do not purchase as everything in this book is obsolete. Some of the forms may be acceptable others may not. Some needed forms are not even included. Besides you can buy the forms packaged at the courthouse for \$5 a packet complete with instructions. There are 4 possible packets but depending on your circumstances all of them may not be needed.This book should be discontinued.
