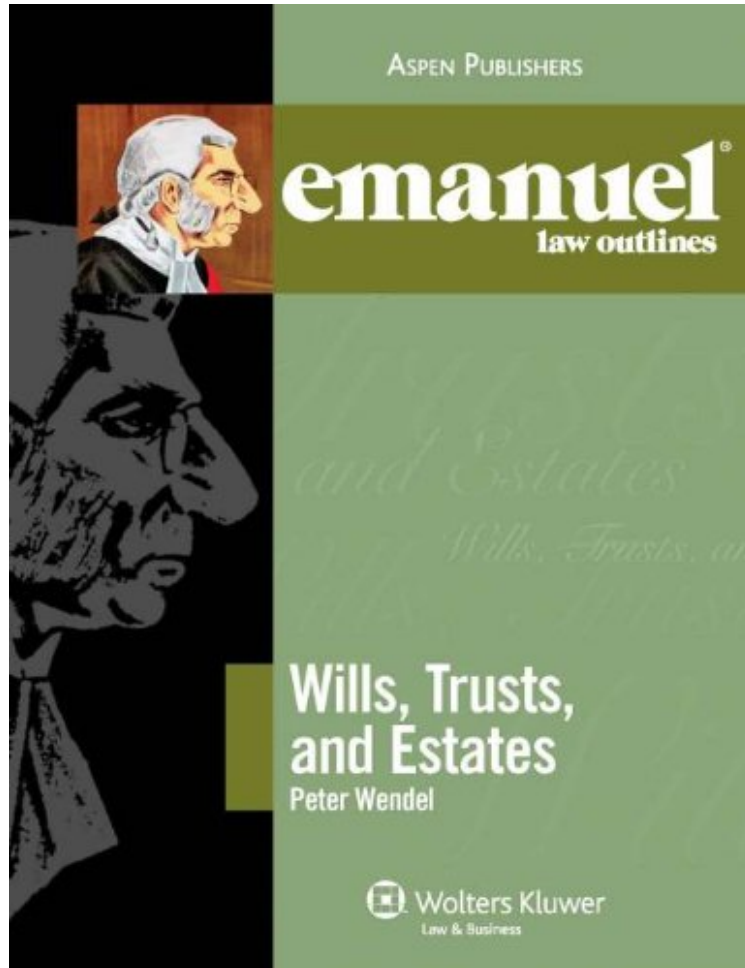

It doesn't appear to have many (or any?) of the 2008 updates to the UPC. I bought this particular outline for the most part because I wanted to make sure everything discussed reflected the updated code. It

doesn't. Perhaps most egregious, the author decided that UPC 2-603 (the UPC's new anti-lapse statute) was too hard to understand, so he left out any discussion on it.
