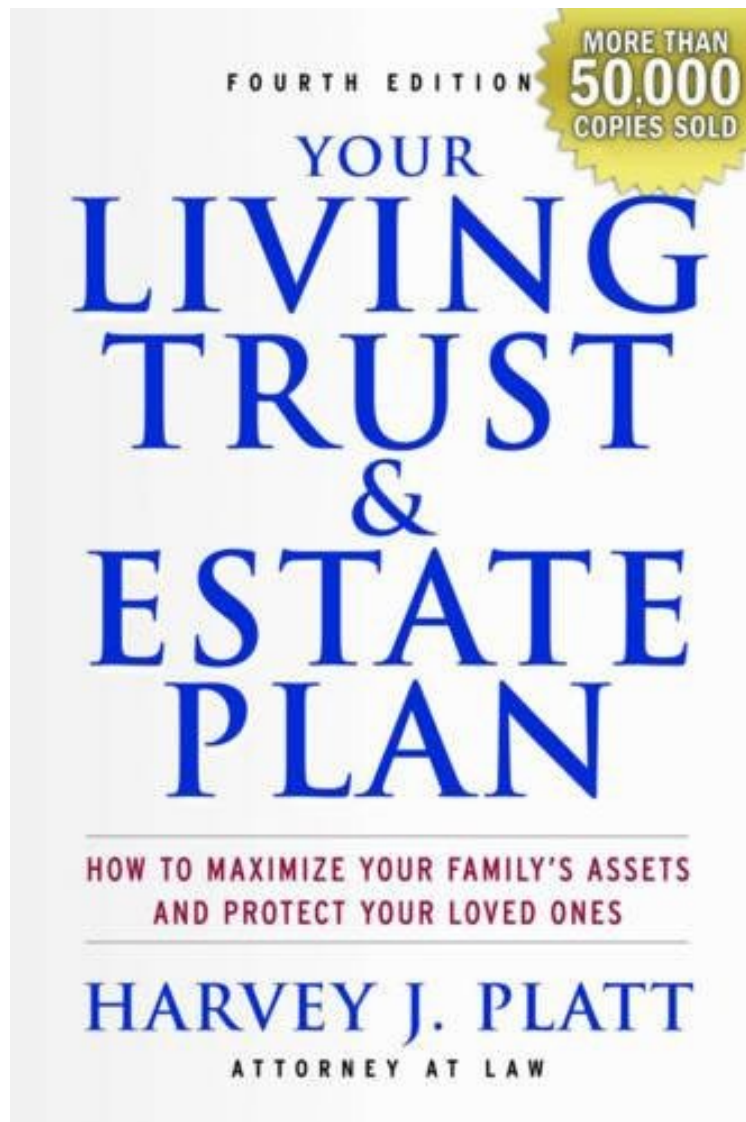

One, it is geared more toward the state of New York, which I wish the author would have made clear. In fact, had I known that, I probably would not have purchased the book to begin with. Two, the author fails to provide samples of the trusts that he refers to. Three, much of the information is also obsolete insofar as the tax laws have changed. If you are looking for practical information that takes into account the changes in the tax laws, then this book fails in that respect. It contains great general information, even though you will still need to find out what applies to you in your specific state. The author practices in New York, as all his examples are for that state. True to Kindle-book fashion, there's a glaring misspelling on location 79.
